# UZBEKISTAN SOON FINISHES THE CONSTRUCTION OF ITS GAS PIPELINE STRETCH TURKMENISTAN-CHINA

The construction of the first branch of uzbek transit stretch of gas pipeline "Turkmenistan - China" is in its completion phase. Pipe laying is going to be completed by August and adjustment works will have been started. The construction of the first branch of gas pipeline will have been completed by December 2009, as it was anticipated.

Gas pipeline Газопровод «Turkmenistan - China» is designed fo the transit of natural gas in volume 30 bln cubic meters per year from Turkmenistan to China.

Russian company «Silovie mashini» has realized the modernization of Sirdarya thermal power plant, the largest heat power plant in the Central Asia. In the process of modernization the overhaul reconditioning of the fifth energy unit with capacity 300 Mvt was realized.

In the process of modernization, lubrication system was fully restored, auxiliary equipment was repaired and installed, pipelines were assembled, supporting overhead system add unit were reconstructed, electrotechnical and adjustment works have been conducted.

The project was financed for account European bank for reconstruction and development credit in amount \$27,8 mln and own funts of «Uzbekenergo».

#### **«NAVOIAZOT» STARTED THE PRODUCTION OF PHOSPHATIZED AMMONIUM NITRATE**

The largest chemical enterprise of Uzbekistan «Navoiazot» bought into production the phosphate ammonium nitrate. The pilot-plant equipment on production of 20 ths tn of phosphate ammonium nitrate has been placed in operation. The capacity of the production line is going to be increased to 180 ths tn by the end of the year. The investments for mastering of new products amounted \$2,4 mln. the project has been financed for own account of the enterprise.

In particular, south Korean ERAE CS Ltd will settle the production of automobile component parts this year in Uzbekistan for the total cost \$32 mln. th company is going to arrange two productions – the production of automobile wires with capacity 130 km per year and with the total cost \$13 mln and the production of generators by machine work method – with capacity 360 ths auto complects and with total cost \$19 mln. The construction of the two plants is supposed to be in the second half 2009.

Indian company Ashok Minda Group is going to build the plant in 2009 on the territory of "Navoi" Free trading area with capacity 250 ths. automobile sets per year. The cost of the project is - \$25 mln.


