### **NET INCOME OF “UZBEKNEFTEGAS” WAS MORE THAN 6 BLN SUM IN 2008.**

17.07.09

National Holding Company “Uzbekneftegas” got net income in amount of 6 bln 8 mln 440 ths sum (\$1-1486,47 sum) in 2008. The acquired income the company distributed for the following purposes: to reserve fund – more than 300,4 mln sum, for needs and industry development – more than 4,2 bln sum, for dividends on shares – 1,5 bln sum. The charter capital of the company hasn’t change – 253,6 bln sum.

### **SASOL, PETRONAS TO STUDY UZBEKISTAN GAS-TO-FUEL PLANT**

Sasol Ltd., the biggest producer of motor fuels from coal, will study the feasibility of a joint venture gas-to-fuels plant in Uzbekistan with Uzbekneftegaz, the national oil company, and Malaysia's Petroliam Nasional Bhd.

The project now moves into the feasibility phase which will be overseen by a joint venture company to be formed between the three partners.

The plant will use Sasol's technology to produce about 1.3 million metric tons of fuels including diesel, kerosene and liquefied petroleum gas, the company said.

### **THE PIPELINE CONSTRUCTION WILL BE ACCOMPLISHED IN DECEMBER**

JV Asia Trans Gas will have completed the construction of the first branch of pipeline “Uzbekistan-China” by December for the Turkmen gas transit through the territory of Uzbekistan. At present more than half of the line is built, it is planned to accomplish the construction of the first pipeline and in the fourth quarter – to realize adjustment works of the whole complex of this line.

### **THE NEW ELECTRIC POWER LINE INCREASED EXPORT OF ELECTRIC POWER**

The state joint-stock company “Uzbekenergo” will have put into operation power electric line 500 kV substation “Guzar” – “Surhan” in Surhandarya region for total cost \$ 137.6 mln. The delivery of the main technological equipment and materials for the total sum \$ 57,5 mln started in July within the contracts of bid winners. The project provides the construction of the electric power line with total length 197 km and installation of two autotransformer with capacity 501 MBA at the substation “Surhan”. The project capacity of the new electric power line will be 800 mVt.

**BEELINE STARTS CONSTRUCTION OF FIBER-OPTIC NETWORK IN UCHKUDUK**

Single communication operator Beeline (Unitel LLC and Buzton JV LLC) started construction of FTTB network (Fiber To The Building) in Uchkuduk city of Navoi region.

Construction of fiber-optic network in Uchkuduk is the second phase of wide-scale project on introduction of new technologies on data transfer in cities of Uzbekistan, which was launched in Zarafshan in November 2008.

Connection to FTTB network allows to connect to single computer group, located in various flats or cities for active information exchange, transfer of video, audio or other files from one computer to another, play games via LAN and others.

It is planned to complete construction of FTTB network in Uchkuduk till the end of august 2009.

**THE ACCUMULATION OF INSURANCE PREMIUM INCREASED 1.5 TIMES TO 63.3 BLN SUM IN THE FIRST HALF OF 2009**

The volume of insurance premium in Uzbekistan amounted to 63,3 bln sum (\$1 – 1486,47 sum) in the first half of 2009, what is 1.5 times more than in the same period last year.

By the results of the first half, 2009 the volume of insurance premium on obligatory types of insurance amounted 24,4 bln sum, what 29% more than in the first quarter and 8 times more than in the first half of 2008. Insurance companies of Uzbekistan paid out 8,8 bln sum of insurance indemnity, what is 60% more that in the same period last year.

This in return lead to the increase in the loss ratio of insurance premium by 1 point. In the result В иторе уровень убыточности за данный период составил 13,9%.

**UZBEK CENTRAL BANK LAUNCHED OWN PAYMENT SYSTEM**

The decree of the Central Bank of Uzbekistan about payment system came into force. The new document defines the order of realization of payments via "Uz-to'lov" system.

"Uz-to'lov" system is designed to accept retail payments from individuals in behalf of recipient as well as money transfer in national currency.

The system provides the full automatization of reception and processing of payments from the population in terms of real time and integration of with banking system, allows to accept payments by any comfortable way – in cash, banking cards, via payment terminals of self service, via systems of distance service and via cell phones.

#### **IPOTEKA-BANK INCREASED CAPITAL BY 7 BLN SUM**

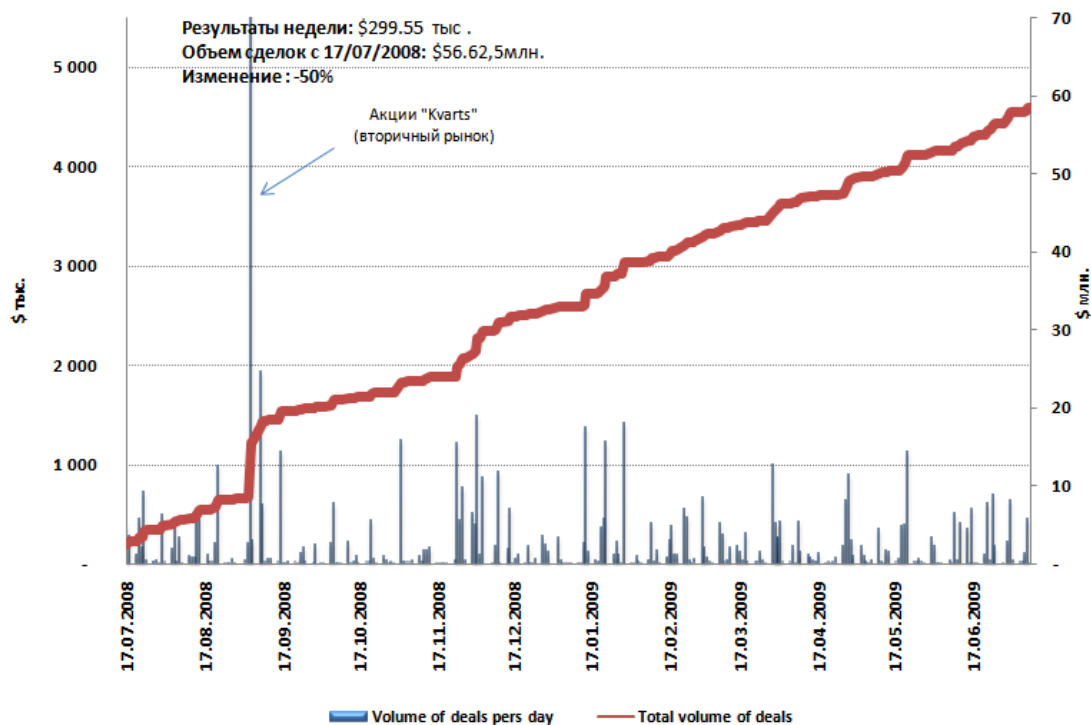
