NHC "Uzbekneftgaz" completed construction of compressor station "Dengizkul" valued \$77 mln. Capacity of the station is 3 bln. m³. The project was financed by loan of KDB bank in amount of \$17 mln., Fund of reconstruction and development of Uzbekistan - \$22.8 mln. and "Uzbekneftgaz" - \$56 mln.

According to new law foreign investors will pay the same taxes and duties as local ones, if anything else is stipulated by the agreement. Also, independently of

agreement conditions foreign investors will pay royalty equally with local ones. Currently working investors will pay royalty after 10 years since production-sharing agreement was signed.

Current demand of paper and cardboard goods in Uzbekistan is equal to 144,000 tones, cellulose – 36,000 tones. Local printing market consumes about 110,000 tones of typographic and offset paper per year. Around 88-90% of raw materials are imported from Russia.

“Suv mash” plant was created in 1971 and was transformed to JSC in 1999. Share capital of JSC “Suv mash” is equal to \$3.22 mln. Workers of the plant possess 2.16% of shares. Main clients of JSC “Suv mash” are in Kyrgyzstan, Tajikistan and Russia.

Their annual capacity is 200,000 tones. Volume of production of construction gypseous in Uzbekistan is 65,000-70,000 tones per year, production of high-strength gypseous is 30,000-40,000 tones.

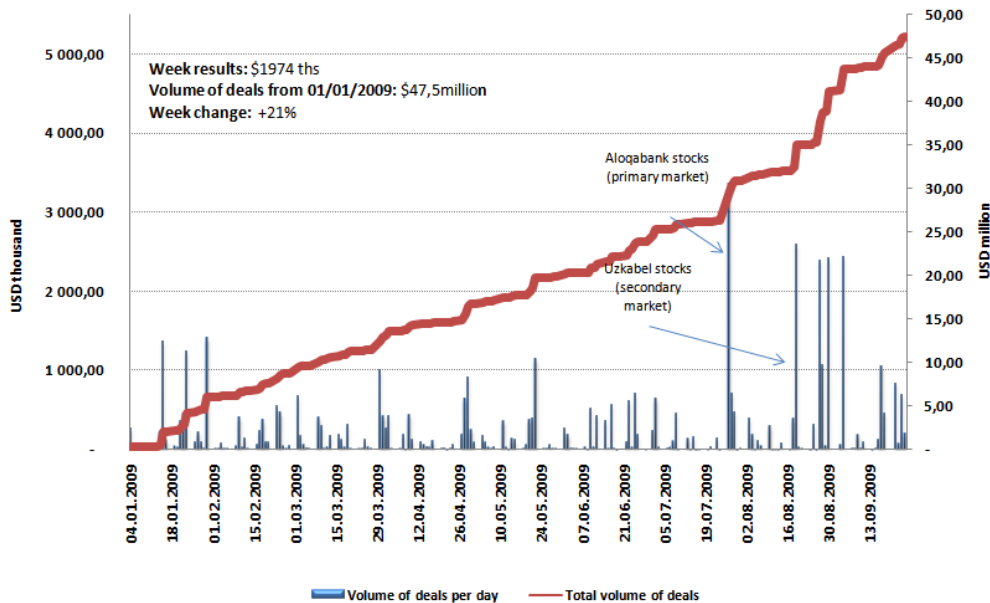
