VOLUME OF INDUSTRIAL PRODUCTION IN JANUARY-OCTOBER 2009 INCREASED ON 9.2%

01.12.09

In 10M 2009 volume of industrial production in Uzbekistan increased on 9.2% in comparison with 10M 2008 up to UZS 23.317 trillion (\$15.25 billion). Share of fuel-energy complex is 31.7%, machinery – 15.8%, non-ferrous metals metallurgy – 11.8%, light industry – 11.2%, food industry – 11.2%, chemical industry – 5%. Share of companies with foreign capital is 17.7%.

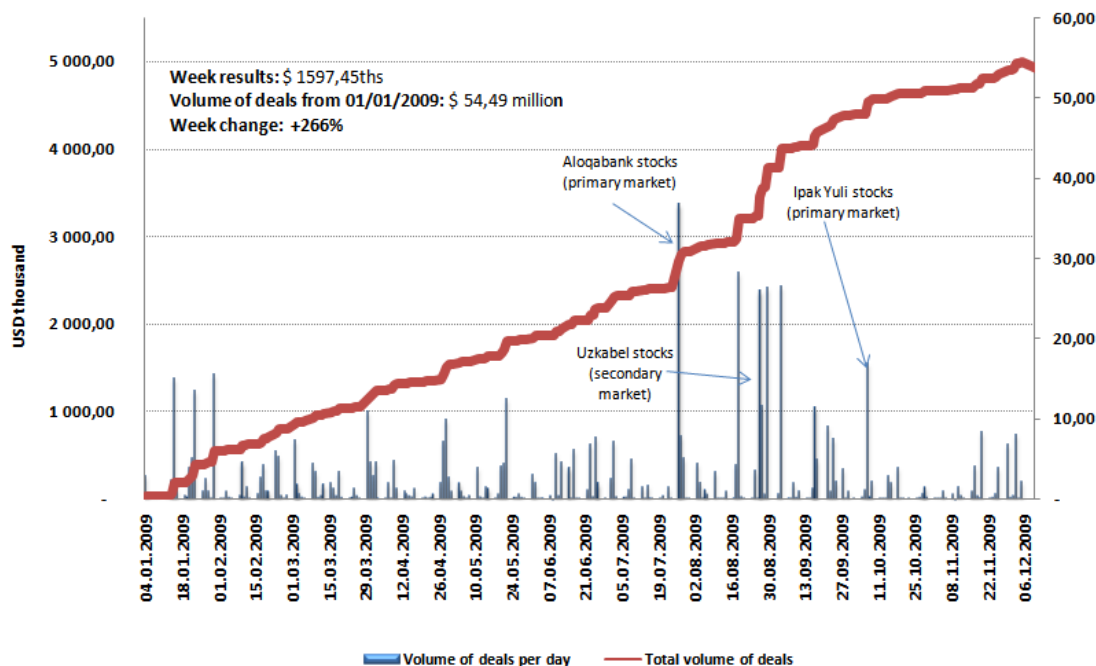
